TWENTY QUESTIONS AN AL-ANON
CAN ASK HERSELF OR HIMSELF....

1. You can admit intellectually, that you are powerless over alcohol; but have you accepted this fact?
2. Did, or do you, resent being married to an alcoholic?
3. Can you see your situation realistically?
4. Can you recognize yourself reverting to old patterns of self-pity and reverse the trend you are taking?
5. Do you sometimes feel or show superiority over your alcoholic mate?
6. Are attitudes of superiority, resentment, etc., affecting others in your family?
7. If past incidents come up, can you respond without bitterness—perhaps even with humor?
8. Have you stopped focusing all your thoughts and attention on your alcoholic partner?
9. Have you REALLY Let go - Let God?
10. Are you waiting for your mate to work the program before you begin?
11. Do you catch yourself trying to control, manage and direct those about you?
12. Recalling past incidents, can you see progress in your attitudes of CALMNESS, OBJECTIVITY, UNDERSTANDING, and SILENCE at such times?
13. Do you think your attitudes (hostility, protectiveness, etc.) MAY have prevented your alcoholic from seeking help earlier?
14. Do you feel that resentments hinder your emotional and spiritual growth?
15. Supposing you sense resentments in your mate, how many of your own have you kept warm, covered up and tenderly preserved? It takes time and energy to nurse a grudge.
16. Recognizing that some of us become extremely independent during the drinking days, do you now include your mate in plans in an effort toward a more normal life?

RASH JUDGEMENT

A fable tells of an ancient Persian King who wanted to discourage his four sons from making rash judgements. At his command, the eldest made a winter journey to see a mango tree. Spring came and the next oldest was sent on the same errand. Summer followed and the third son went. When the youngest boy had returned from his autumn visit, the King called them together to describe the tree.

The first said it looked like a burnt old stump.

The second disagreed, describing it as lovely in lacy green.

The third declared its blossoms were as beautiful as the rose.

The fourth said all were wrong. "Its fruit was like a pear."

"Each is right," the king said, "for each of you saw it in a different season."

And so it is when we view another's actions. We should withhold judgement until we are certain we've seen "The tree in all its seasons."

The Mid-Timer

Have you begun to feel comfortable in your sobriety? Is it becoming habit-forming? Have you been group secretary at least twice, and are you looking forward to your first area meeting as GSR? Do you feel much older and wiser than the current crop of newcomers, and yet can't identify with those "remember when-ers" with the long gray beards who have been sober for eons? Relax, chum, there's nothing wrong with you. You're a mid-timer!

We mid-timers have much to be grateful for. Not too long ago we were wishing we didn't have the shakes; now we not only don't have them, but its becoming increasingly difficult to remember what they were like. Not too long ago we were asking some guy who looked like he never had a drink how to stay away from one; now we not only know how, but we are telling some other poor guy with the shakes how we did it. We wondered if the program would ever work for us; now we know that it has.

Before you get too carried away with your success, I might as well tell you that you have reached a crisis period in your recovery. Are you going on fewer Twelfth Step calls lately? Is it easy to miss a meeting occasionally? Did you pass up that last chance to speak, simply because you wanted to see a TV program? You have "mid-timers let-down."

A mid-timer has a much better chance of staying sober than a newcomer. But don't be misled by mere statistics. Remember, you got to be a mid-timer only by hard work, and you'll never get to be an old-timer by goofing off. Don't let that old enthusiasm wear too thin, because if it ever breaks you may be in real danger.

We have spent the last few years finding out how to stay sober, during which time we have learned that participation is as important as education. We may think we know all about the program, but at this stage knowledge alone is not going to suffice. We still need the fellowship, the giving, the sharing. Complacency is our enemy and could destroy us.

How, you ask, is it possible to keep the old enthusiasm sharp? Well, for one thing, ask not what AA can do for you; ask what you can do for AA. Seriously, we have spent the last years mastering a set of principles for our own use and benefit. A selfish program, we called it.

Well, maybe the time has come to think of helping AA as well as ourselves. After all, AA is growing and changing all the time (slowly, I'll admit) so why not have a hand in it?

"How?" you ask. Well, this depends, of course on where you live. If AA is well-organized and well-oiled in your area, chances are you are already one of the important cogs. But if AA in your town is new and faltering, or old and sick, you're really in business. Help start a group.

Help start an intergroup. Organize an institutions committee. Organize a speakers committee.

Or, if you're interested in twelfth stepping 45,000 people all at once, do what I do. Write articles for the Grapevine. (Amen-Ed.). J.S.C., New Hartford, Conn.

YOUR TREASURER'S LAMENT

Orange County Intergroup's Central Office will be four years old next February. It is a going concern, filling very real and varied needs not possible by individuals. Currently it is solvent. That is, its bills are paid and has cash enough on hand to operate for about 45 days should all income cease. I suppose, as AA goes, this could be considered unusually healthy. But from a business point of view, this is a meager buffer against fluctuations and/or emergencies.

A point of more concern to me is the nature of our income. Only 66% is from group support by contributions. The Office has two main functions: to aid the alcoholic who wants help, and to service the groups and individual members in many ways.

(The first 8 months shows the Central Office will handle over 8000 calls for help or information in 1965.) How could a few individual members be listed and reached; how could they individually be equipped with answers, information and referrals for a volume like this? How about their telephone bills? And literature? And speakers? And 'Where is a meeting'? And etc.?

34% of income has come from 'special

events', Answer the Call (small, and individual contributions (quite small)). Income from special events is unpredictable, has been negative, and could be disastrous. Also, your Board members get their share of complaints and snide remarks about these Intergroup dinners, dances, picnics. They are a lot of work, and should not be necessary. So far they are 34% worth.

Many groups support Intergroup (which set up and runs Central Office) generously. Many support it to the best of their ability. Some disregard, and a few even resent it. Again, in AA this is their privilege. (In this case, to me, a doubtful one.)

Responsibility was the keynote of the recent Toronto convention. AA growth and unity in Orange County depends on individual and group responsibility towards their common aims and needs.

I personally, look forward to the time when we will have dinners, dances, or what have you just because we want them. Not because we need them for our unified existence. Harry M., Treasurer, Central Service Board.
