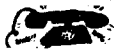

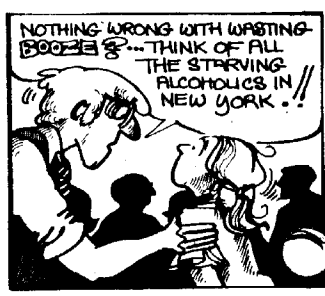

POLITICS-- TO THOSE WHO DON'T SERVE' . . . . .

"Why should my group or I support such things as the Central Office, the General Service Office or the Area Committee? After all, isn't all that stuff just a lot of politics, so that a few people can act like big shots?"

Arguments like these have been with us since the early days of AA. Even before there were central offices, area committees or a G.S.O., some members said, "Why should we help write or finance a book about our recovery so that others may reap the benefits from it?"

Thank God there were others who said, "We must preserve our experience, our strengths and our hopes so that others may have a chance at sobriety. We must have an office where we can receive and answer inquiries. We must provide certain services to assure our own unity and the chance of recovery for countless other still suffering alcoholics. This is a debt we owe for our own sobriety."

A few persevered and with the help and cooperation of Bill and Dr. Bob spread out to form new groups, central offices and state committees. These combined with G.S.O. have grown and unified into what is known today as the A.A. Service Structure.

There are guidelines, pamphlets and books available at your Central Office explaining what services each of these offices or committees are responsible for.

It has been said that politics is a word used for service in A.A. by those who will not serve. Whether they want to call it politics or service, I want to help pay my debt to other alcoholics by supporting these services with the time and money needed to assure that others will have the chance at sobriety that was given to me.

The 60-30-10 Plan was endorsed by the groups through the A.A. General Service Conference as an effective way, if followed, to help support (along with individual donations) these three vital A.A. Services.

The pamphlet "The AA Group" explains: Usually, passing the hat at meetings takes care of the group's money needs, plus something left over so the group can do its fair share of supporting the central office (or Intergroup) office, the Area Committee, and the General Services Office.

"Most groups now find it makes good sense to budget all expenses in advance, setting aside sums from each collection in order to meet monthly pledges and bills."

"A.A. experience clearly shows that it is not a good idea for a group to accumulate large funds in excess of what is needed, plus a prudent reserve." pp 10-11 Group Pamphlet.

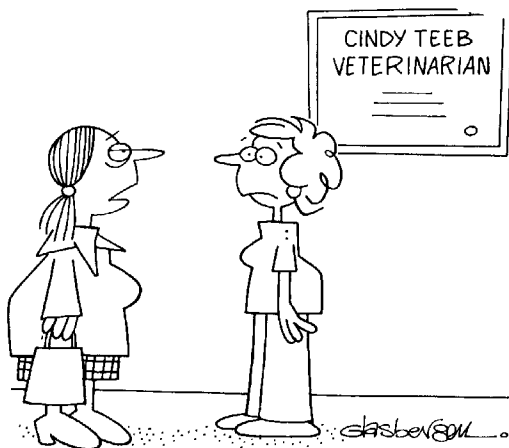
Most groups want AA as we know it, to endure, and to be readily available to any other alcoholic who comes along needing help.

Therefore, they make a pledge or commitment of a certain amount each month with 60% going to their Central Office, 30% going to the General Service Office, and 10% going to their Area Committee.

Most of us are sick and tired of the often heard cliché that alcoholics are immature and therefore probably not able to successfully handle their own affairs. Let's prove them wrong!
